Summary of key findings for parents

This provision is good

- The childminder and her assistant plan exciting experiences that help to engage children and support their learning well. All children make good progress in their learning, given their starting capabilities and interests.
- Children behave well. The childminder and her assistant help children to develop their understanding of routines and boundaries well. They encourage and praise children who learn to take turns, share and show respect for one another.
- Partnerships with parents are effective. For example, the childminder and her assistant keep parents fully informed about their children's progress and well-being. They provide ideas, which helps them support their children's learning at home.
- The childminder actively pursues training opportunities for herself and her assistant. She works closely with the local authority team, and carries out relevant training. This helps her to raise the quality of her provision and children's overall learning experiences.
- At times, the childminder does not deepen older children's understanding of mathematics.
- The childminder does not work closely enough with the other early years settings that children attend to help support children's learning and care more consistently.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- review and improve the learning opportunities for older children to further develop their mathematical skills
- implement arrangements for exchanging information with other settings that children attend to ensure there is continuity in learning and care.

Inspection activities

- The inspector observed the quality of teaching during activities and assessed the impact this has on children's learning.
- The inspector and the childminder jointly observed the assistant and children, and evaluated an activity together.
- The inspector looked at areas of the premises used for childminding and sampled relevant documentation, including children's records.
- The inspector held discussions with the childminder and her assistant, and spoke with children at appropriate times during the inspection.
- The inspector reviewed parents' feedback by sampling written documents.

Inspection findings

Effectiveness of leadership and management is good

Safeguarding is effective. The childminder and her assistant understand the potential signs of children at risk and the procedures to follow if they have any concerns regarding children's welfare. They have completed training on wider safeguarding issues, and undertake regular risk assessments to help keep children safe and secure. The childminder monitors her practice well. For example, she recently carried out training to support children with their speech and language to extend their communication skills further. The childminder regularly monitors and tracks children's achievements effectively and quickly puts plans in place to help them catch up. Parents are highly complimentary about the care their children receive.

Quality of teaching, learning and assessment is good

The childminder and her assistant use good teaching skills to extend children's learning through their daily activities and routines. They help younger children to develop their understanding of language and support their speaking skills well. They help them become confident talkers. For example, children share books together and point out the different animals in the pictures while the childminder and her assistant introduce new words. The childminder plans exciting activities and experiences to motivate and stimulate children's curiosity. For instance, children used tweezers to pick brightly coloured pom-poms and place them in cups. The childminder and her assistant skilfully extend their learning further, such as by asking them to sort, match and identify the different coloured pom-poms.

Personal development, behaviour and welfare are good

The childminder and her assistant are kind, and are attentive to children's needs. They closely follow children's familiar routines and quickly respond to their individual needs. Children demonstrate they feel extremely confident, safe and secure in the childminder's home. Younger children settle in well and show a strong sense of belonging. The childminder promotes children's confidence and self-care skills well. For example, younger children follow good hygiene practices as they learn to wash their hands independently. The childminder helps children to enjoy the benefits of a healthy lifestyle. For instance, children enjoy healthy meals and snacks, and develop strong physical skills as they practise their small and large muscle movements indoors and outdoors.

Outcomes for children are good

Children make good progress from their individual starting points. They gain useful skills for their future learning, including for when they move on to school. Younger children demonstrate a strong willingness to explore their surroundings, and eagerly join in with activities. They develop good early writing skills as they draw and make marks on boards. Older children develop a keen interest and enjoyment of books, and show enthusiasm in all their activities. They are eager to learn.
